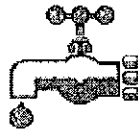

CONSUMER'S AGREEMENT

THIS AGREEMENT, made and entered into this.....day of ....., 2020, by and between the  
MONROEVILLE MUNICIPAL AUTHORITY, a municipal corporation organized under the laws of the  
Commonwealth of Pennsylvania hereinafter referred to as "Authority",

AND

PA 15146) Allegheny County, Pennsylvania, hereinafter referred to as "Owners".

WHEREAS, Owner has requested the installation and connection of a water service and meter for the premises of  
the owner located at .....; and

WHEREAS, the Authority has agreed to provide water service for the said premises in accordance with the rules and  
regulations as now in effect and as may be adopted by the said Authority.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, it is agreed as follows:

1. The Authority shall install, connect and extend water service from the water main of the Authority to a  
curb box in the public Right-of-Way near the premises of the Owner and shall install a meter in a satisfactory  
location provided by the Owner; and Owner agrees to pay the Authority for said installation the prevailing rates and  
charges of the Authority as are now in effect. Owner shall be solely responsible for the installation and maintenance  
of a service line extension from the curb box to an approved meter location. The method and materials used in the  
installation of the service line shall be inspected and approved by the Authority.

2. Owner agrees to exclusively use water furnished by the Authority and to pay therefore within fifteen (15)  
days of the date of the bill. All accounts shall make payment for all water consumed upon said premises, at the  
prevailing rate or at such rates as may be determined by the Authority in accordance with a rate schedule. A  
schedule of current rates may be obtained at the Water Authority office.

3. Authority acknowledges the receipt of the sum of \$25.00 from Owner as a security deposit held by  
Authority in a "Security Deposit Account". The said sum shall be refunded by Authority to Owner upon Owner's  
request, in writing, for the termination of water services provided; however, there is then no outstanding  
indebtedness to Authority. In the event that there shall be an indebtedness to Authority as of the date of Owner's  
request for refund, or, in the event of Authority's "shut-off" of water service in accordance with the Authority's  
rules and regulations, then Owner agrees that the security deposit set forth herein shall be applied by Authority to  
Owner's Indebtedness for said account. Any credit in excess of final bills shall be returned to Owner.

4. Owner acknowledges that that Authority has adopted fair and reasonable "shut-off" procedures that are  
incorporated in Authority's rules and regulations. In the event that Authority has fully complied with said  
procedures by reason of Owner's non-payment of water charges, then Owner does wave, surrender and discharge  
any and all claims of any nature whatsoever against Authority by reason and of arising from Authority's termination  
of water service to the subject premises.
